This subcommittee is formed to investigate possible means of conducting a Nova Scotia Duck Tolling Retriever health survey. The subcommittee is to report to the Board of Directors of the NSDTRC (USA) with their findings. Findings are to include (but are not limited to):

- Comparison of using the Orthopedic Foundation for Animals breed health survey currently available versus developing one of our own on the Club's website, including feasibility of each.
- Investigate what geographical regions of tollers to include in the survey.
- A comparison on the previous health survey by the NSDTRC (USA) and the proposed new survey, including:
  - o How the new survey would differ from the old.
  - o How the proposed survey will be improved over the old.
  - o How the old survey results were tabulated compared to tabulating the new results.
  - o Comparison of how health issue have increased or decreased from the first health survey to this proposed survey.
  - o Analysis of toller longevity from the previous health survey to the proposed health survey.
- Identification of which health issues are most prevalent in the surveyed tollers.
- Make the results of the old survey available for club members to compare with the new health survey.
