## Standardized Specialty Ribbon Committee, formed in 2019

Submitted by Committee Chair J. Annunziato

**Purpose:** To Create and build a Rosette Bank to offset the cost of rosettes for National Specialties

Committee member, Anne Lindsey, supplied the committee with the AKC requirements for

Rosettes for Obedience, Rally, and Conformation as of 2023 - Attachment B

### History of Bank

We started building the bank with the 2022 National Specially in PA with Obedience, Rally and Agility Placement, New Title and Q Rosettes. A shareable Google spreadsheet was created by the 2022 National Assistant Event Chair, Francine Kaplan to track the number of rosettes required for Obedience, Rally and Agility and to record the number of rosettes being passed on to the 2023 National Specialty.

There were 394 placement rosettes delivered to me as Chair of the 2023 National and I replaced the center streamer on each for \$0.80 each to create generic center streamers.

Side Tabs were then ordered to specify the venue, i.e. Obedience, Rally or Agility. Side Tabs cost \$0.18 so all rosettes could be passed on.

The Date, Place, and Year of the national was printed on labels and placed on the back of the Rosettes by the Ribbon Chair, Janis Neff when they picked up their ribbons.

This resulted in a significant savings to the Club of approximately \$1,800.00 in 2023.

National Specially 2023 - all Rosettes were ordered for classes, Qs and New Titles based on conformation and performance Specialty classes. All unused 2023 Rosettes were inventoried and shipped to Shelby Westmoreland for the 2024 Specialty In Lodi, CA.

There are conformation rosettes in this Shipment that can be reused if the center streamers are replaced. Replacing the Center streamer of left over Conformation rosettes is a fraction of the cost of purchasing new ones.

Attached to this report is an inventory of the placement, Q and new title rosettes sent to Shelby Westmoreland, Chair of the 2024 Specialty. The costs savings to 2024 based on today's prices is approximately \$2,409.62 **Attachment C** 

Cost (today) minus Hodges shipping, tax and set up fees:	\$2,764.80
Shipping fees from Joy Annunziato:	\$255.18
Cost of center streamer replacement for 2024	\$100.00
Savings for 2024 is approximately:	\$2,409.62

**Summary:** As demonstrated in this report, already the savings to the club of creating this ribbon bank is exponentially increasing year to year and creates significant savings to the club, even with having to mail them to the 2024 Chair. It is expected that by the time 2024 orders their rosettes the prices will have increased and the club will save even more.

Our committee has completed its task and hope this Rosette bank will continue to grow. I will be sharing the google docx with the 2024 National Specialty Chair. We thank you for the opportunity to serve.

**Proposal #1:** Redefine Handler Eligibility in NSDTRC (USA) Sweepstakes events. **Submitted by:** Travis Massie, Barb Rohr, And Sweepstakes Handler committee.

**Proposal Description:** Replace the current policy "Professional Handlers are not eligible to compete in sweepstakes at NSDTRC (USA) events" with "Professional Handlers are not eligible to compete in sweepstakes at NSDTRC (USA) events unless they are an owner, co-owner and/or breeder of record of the dog(s) being handled."

**Proposal Justification:** We have concluded our two-week questionnaire and after further review of the answers from the members, the option that had the majority vote was Option B (*Professional Handlers are not eligible to compete in Sweepstakes at NSDTRC (USA) events unless they are an owner, co-owner and/or breeder of record of the dog(s) being handled.)* The runner-up behind Option B, was Option A (*There are no restrictions on who is eligible to handle a dog competing in Sweepstakes at NSDTRC (USA) events.*) with, the overall members want change from what the current policy is (*Professional Handlers are not eligible to compete in Sweepstakes at NSDTRC (USA) events*).

Breaking down the data, Option B had 19 votes, Option A had 15 Votes, And Option F had 13 votes. Diving into Option B's votes, we have two members that are invalid due to not being voting members (not in the roster) so that brings Option B to 17 votes. Now looking at errors in the votes, we had a member not cast their vote correctly and answered with (6,1,2,2,2,6) so if we throw that vote out it brings Option B to 16 votes.

On the Questionnaire, we asked the members "How much experience do you have competing in conformation?" after reviewing the 58 valid votes, 0-5 years (9), 5-10 years (12), 10-15 years (7), 15-20 years (8), 20-25 years (8), 25+ years (14). After reviewing, for the votes between 0-5 years' experience, Option A had 4 votes, Option B had 2 votes, Option F had 1 Vote, and 2 others between Options C, D, and E. Moving forward to the most experienced of 25+ years, we had 14 selections among the members, Option A had 3 votes, Option B had 5 votes, Option F had 4 votes, and the last 2 had selections between Options C, D, and E.

Looking across all the Regions, from region 1 (9 Members), region 2 (18 Members), region 3 (3 Members), region 4 (1 Member), Region 5 (8 Members), region 6 (9 Members), and with region 7 (10 Members). Total 58 valid votes.

If our top 3 picks would have been Option B, Option F, and then Option A. I would say we need to dive deeper into reviewing. But with these results, clearly the overall membership of NSDTRC-USA would like to see change among the policy.

In conclusion, with the votes from the members, we are looking to proceed with terminating the current policy "Professional Handlers are not eligible to compete in Sweepstakes at NSDTRC (USA) events" and replacing it with "Professional Handlers are not eligible to compete in Sweepstakes at NSDTRC (USA) events unless they are an owner, co-owner and/or breeder of record of the dog(s) being handled."

**Administration:** Update the National Specialty Manual, Specialty Guidelines, and Supported Entry information.

Financial Implications: Potential increase in numbers for Sweepstakes at NSDTRC (USA) events.

**Proposal Description**: Proposal for a fund-raising event for the 2024 Nova Scotia Duck Tolling Retriever National Specialty. The event will be an Obedience & Rally Show and Go held on Sunday, March 24<sup>th</sup>, 2024, in Placerville, California at the Competition Canine facility. The Show and Go would allow run-throughs (trial-like competition) for Rally and Obedience to give participants a chance to practice for upcoming trials.

The goal of the Show and Go is practice skills in a trial-like environment and not for competition. Therefore, the performance will not be scored and no ribbons will be given out. An experienced person will be assigned to each ring to run through the participants much as a judge would and give feedback as requested. The person serving as the "judge" will not need to be an AKC sanctioned judge since this is not an AKC sanctioned event.

The Competition Canine facility has been reserved for this event pending approval from the Club and ability to get insurance.

# **Proposal Justification**: The purpose of the Show & Go is to:

- 1) Raise funds for the 2024 Nova Scotia Duck Tolling Retriever National Specialty
- 2) Provide an opportunity for people in Sacramento and Placerville area to practice skills needed for obedience and rally competitions. While participants will not be limited by where they reside, this type of event is generally only of interest to people that reside within a 2-hour drive of the event.

No conflicting AKC Obedience or Rally trials are scheduled for this date (3/24/24) within 100 miles.

**Administration**: This is a one-time event and thus no on-going administration is required by the Club. This event is not expected to be of interest to people living outside a 2-hour driving distance (although all are welcome to participate). So, no Club advertisement is needed at the USA level. Event notification will be sent to Region 4 members via email.

Financial Implications: The owner of the Competition Canine facility (Ann McQuillen) has agreed to a fee of 30% of the proceeds from the event for use of the facility and its equipment. Other expenses are expected to be 1) printing of flyers for advertisement and 2) any expenses needed to cover collection of entries and fees. All workers (Judges, Stewards, and any supporting people) at the Show and Go will be volunteers. Each volunteer will be offered 1 free entry in appreciation for their help.

Proposal #3: Revise the Versatility Program

**Special Thanks:** I would like to thank everyone who helped me write and edit this program. The individual sport expertise that was offered was greatly appreciated and helped me balance this program appropriately.

**Description:** A rewrite of the versatility program to:

1. Get back to our original program structure by sport.

- 2. Re-balance the sports based on training requirements and sport type and focus the program largely on performance versatility.
- 3. Give members achievable steps between the Rusty Jones and the Eddy Versatility Awards.

### See Attachment D for the program rewrite.

**Justification**: With new sports and new training theory, it is appropriate to also look at and reassess versatility programs. This program is split into two main categories: Companion and Performance.

These designations come largely from AKC and how they classify their sports, with the exception of tracking which has been placed in the performance category. The reason for both the names and the adjustments has to do with the category definitions:

**Companion** sports are human-led sports; where training, cues, and direction largely come from the human to the dog. **Performance** sports are the opposite; while still requiring a high level of training, the human is the minority role and dog behavior/instinct is the driving factor.

When these two are combined is when you see a well balanced, confident dog who is truly versatile.

The big change to this program from past programs is giving conformation a complete backseat. It is impressive when a dog can succeed in both the conformation ring and in sports, and points will still be awarded, but the evaluation of breeding stock does not make a dog versatile.

The other major change is levels, this program includes four: Versatility Certificate, Versatility Excellent, Versatility Master, and Versatility Champion. These are achievable steps leading up to the Eddy versatility, and hopefully encourage more people to put champion level performance titles on their dogs.

Specific questions I would like to point out that came up in feedback:

- Barn hunt does include a high level of training, especially to the higher levels. This is not a "gimmie sport", nor is it a "show up and Q" sport. This requires hunting drive <u>and</u> the precision of scentwork.
- Fast Cat: The average Toller's FCAT takes 45-46 runs. While it is hard to fail at fast cat, the higher level does take consistency which is why the FCAT has been placed at 3 points.
- Invitationals: Any invitational counts for categories 1 and 2. This requires such a high level of training past the champion title, and even higher to then succeed and qualify in this environment. These accomplishments should be awarded.

**Administration:** At a minimum, just swapping out the old program and the new program with the records chair. However, I would like to see the re-formation of the versatility committee that

existed in the 2000s. There are so many sports these days, and some of these applications may need to be evaluated on a case by case basis.

Financial: No differences from the current program.

- o Bring new exhibitors to the sport. In Conformation, Companion and Performance events.
- o To build a Breeder Base. Without Breeders our sport cannot continue.
- o To have a healthier membership base for clubs. Volunteers are needed for the future of our clubs.
- O To deliver our message and reach new people. Young people can assist us in delivering positive communication about the sport and their involvement through social media allowing us to reach a broader audience.

**Proposal #6:** To Make Morris And Essex 2025 a Designated NSDTRC (USA) Specialty **Submitted by:** Rochelle Kurth

**Proposal Description:** NSDTRs have been invited to be a specialty at the 2025 Morris and Essex dog show. This show is held once every 5 years and is held as a traditional 1920s dog show. While this does fall under the NSDTRC-NE mileage range for hosting specialties and they are happy to host it, I strongly feel the NSDTRC-USA should host this.

The date is October 1, 2025 in Colonial Park, NJ

**Proposal Justification**: The Morris and Essex dog show is a historical show and one of the largest in the country - if not the largest - every year that it is held. In the years that it has been held, this show has not had fewer than 2000 entries since 1933. The last two shows were around 4000 entries.

This show is held traditionally, so there are no sports in conjunction and we will not be able to have hunting/working as these classes did not exist in 1920. We might be able to have veterans and awards of merit. However, the numbers do fit per our specialty policy.

- 7. Rosettes for Best in Sweepstakes and Best of Opposite Sex in Sweepstakes.
- Clubs may contribute their own trophies which will be listed in the catalog.

Specialty-holding clubs must have prior approval from AKC for all classes including sweepstakes, Veterans, etc. before they can be listed with us. Clubs must apply to the AKC to hold a sweepstakes in conjunction with Morris & Essex Kennel Club. Deadline for submission to AKC is five (5) months prior to the closing date of the show. However, in order to be included in the premium list and catalog, you must submit a copy of your application to the chairman listed in this correspondence NO LATER THAN February 1, 2025.

Even if you are not planning to hold a sweepstakes, please send your list of club officers and your trophy donor information to the chairman listed below no later than February 1, 2025. Clubs may provide their own trophies. In order to be listed in the catalog the names of donors and the items offered must be sent to the show chairman and to the trophy chairman NO LATER THAN February 1, 2025. If you can estimate the number of trophy tables you might need, please let the trophy chairman know.

### SUBMITTED FROM THE FLOOR VIA VP MELISSA SAVAGE

**Proposal:** To approve official NSDTRC (USA) participation in the AKC Meet the Breeds event at the Javits Center in New York City on January 27 and 28, 2024 Submitted By: Margaret Aldridge and Mary Palkowski, Public Education Committee (PEC) Cochairs.

**Proposal Description:** The AKC Meet the Breeds tour is headed back to NY, and the PEC is proposing that the NSDTRC-USA be represented at the event.

Club Member and Board Member Annie Garwood has been submitted as onsite booth coordinator on AKC application. We hope for an assistant coordinator and are working on recruiting other toller owners to bring dogs.

For each of the Meet the Breeds events, AKC has developed standard booths for AKC breeds. No decorations are needed. It will be the NSDTRC (USA)'s responsibility to have dogs at the booth to meet visitors, and to provide any handout materials. The PEC will work with Annie on both these responsibilities.

All volunteers at the booth will be required to sign the NSDTRC's approved waiver.

The Meet the Breeds events will comply with all local and federal health and safety requirements in effect at the time of the event. Our booths at both Chicago and Columbus in 2023 were highly successful.

**Proposal Justification:** In previous years, AKC has organized Meet the Breeds tour events in several cities throughout the country. During COVID, the NSDTRC (USA) Board of Directors declined to officially participate in these events. The PEC believes it is important for our breed to be represented at these events going forward. They are an opportunity to fulfill our obligations as an AKC parent club to educate the public about our versatile breed and responsible dog ownership. Other parent clubs have raved about the success of these events and how positive they have been and our participation in both the Chicago and Columbus events was very successful, with our booth being one of the most popular at those two events. NY will be the first Meet the Breeds event of 2024. Just for the BOD's information, we have not yet heard about AKC's plans for additional Meet the Breeds events in 2024.

AKC may begin listing participating parent clubs online and in print informational materials prior to the deadline, so the PEC would like to register as soon as the BOD has approved the event, and the Club insurance company has been notified.

**Financial Implications:** As they did in both Chicago and Columbus, the AKC has announced that a \$300 per day "stipend" will be available for parent clubs that have at least four dogs at their booth, and \$500 for those that have five or more dogs. We earned the full \$1,000 stipend from AKC for Chicago, and \$300 for Columbus, which was a one-day event.

In addition to the stipend or reimbursement, AKC has announced it will provide free admittance and lunch vouchers for up to five volunteers each day.

The PEC would like to ensure our volunteers feel valued for the time they give to work at the booth. Most live a distance from the Javits Center venue for the event, so we are planning to utilize the stipend toward reimbursement to our volunteers for mileage to the event and parking.

In addition, we would like to provide up to five volunteers each day with a custom grooming apron (also done in Chicago and Columbus) that helps visitors identify them as a booth volunteer and serves as a memento of their Meet the Breeds experience. We propose that the NSDTRC (USA) cover the expense of one apron for each of five volunteers at Meet the Breeds NY. We would allocate a total of no more than 10 aprons.

We propose that the AKC stipend (either \$600 or \$1,000, depending on the number of dogs we have in attendance) would also be used to cover one handout to be used at the booth and business cards that include the NSDTRC (USA) website and PEC email address. The Chicago and Columbus events were completed within this budget, and we believe that the NY event will be successful with the same budget parameters.

**Specific Board Action Requested:** Approve this proposal to officially participate in the AKC's Meet the Breed event in New York on January 27-28, 2024, appoint Annie Garwood as on-site coordinator of the NSDTRC (USA) booth and approve NSDTRC (USA) expenditures of up to \$300 in addition to the AKC stipend.
