An update from the Health and Genetics Committee – August 2024 Submitted by Karen Bauman

Happy summer to all!

Website changes

Although most of you are hopefully spending summer outside with your tollers, next time you are at your computer please check out the updated webpage on the Club website (https://www.nsdtrc-usa.org/health/overview/). In addition to an updated summary and background on the OFA Canine Health Information Center (CHIC) program (see also our 2022 article in Quackers), new information has been added, including:

- A link to the International Partnership for Dogs (IPFD) which hosts the Harmonization of Genetic Tests for Dogs Initiative, a global effort to provide reliable information on gene tests (see the genetic testing tab). The site provides summaries of diseases/conditions, and related scientific publications, as well as companies offering testing for the disease/condition. This website (DogWellNet.com) is endorsed by the AKC Canine Health Foundation (CHF).
- A link to an excellent four-part webinar series from 2020 that the AKC CHF provides for free, called the *Review of the current state of genetic testing in dogs*. This webinar is designed for breeder and owners, and provides an excellent background on this topic.
- A link to the page on the AKC CHF website where you can find all the amazing podcasts, updates and webinars they provide for free. A great resource on everything from canine cancer to tick borne diseases.

Updating breed health and genetic testing recommendations

There has been significant progress made to address a concern submitted by several members (via a proposal to the Club Board), which requested the committee update the information currently listed about the recommended health and genetic testing for tollers on AKC website (health section) and the CHIC program. In brief, the justified concern was that the information on the two webpages did not match and they were both out of date. The goal since that proposal has been not just do a one-time fix, but to set us up for the future with a transparent and complete process.

Below are highlights of what has been done thus far:

- A protocol has been created to assure these testing recommendations are reviewed more frequently moving forward. This will also assure that the AKC and the CHIC recommendations are updated synchronously, so both should contain the same information moving forward.
 - Nothing like this previously existed for our committee, nor could I find any recommendations from CHIC or AKC, so this is completely new.

- Currently the protocol calls for a review by the committee at set intervals, e.g.
 every 3 years. However, importantly, the protocol also requires a review to be
 triggered sooner in the event of a health issue that has significant impact on the
 breed (where not testing might cause harm to the genetics of the breed or
 comprise the welfare of a great number of tollers).
 - For example, had this protocol been in place, the discovery of cardiac laminopathy (CLAM) would have triggered a review given that CLAM is a fatal heritable condition.
- A decision tree has been created to objectively evaluate the tests available for tollers
 to determine breed specific recommendations. By establishing a set of questions and
 the potential responses in this format, the outcomes can be more easily understood
 and readily documented. The use of a decision tree format also provides transparency,
 removes the potential for bias (intentional or unintentional) and allows for continuity
 going forward.
 - o Some examples of the questions are:
 - does this condition have breed-wide implications?
 - is the condition lethal?
 - is this condition inherited?
 - is there a test, and has it been validated for tollers?

Recently an in-depth status report was given to the Board (summarized in this update for all members) and received positive feedback. The draft protocol and decision tree is ready for expanded discussion with new committee members (new committee members have been submitted for board approval), as well as a review by a diverse group of expert advisors. Once this is done and we've incorporated the edits, everything will be submitted to the board for final approval. Assuming the protocol and recommendations are approved, we will work with the Club President to formally request these changes be made to the AKC and CHIC sites; the health page of our website will also be updated. The hope is to have this completed as soon as possible – the goal is by the end of 2024, or sooner (if possible). We understand that many members are anxious to have this completed, but I hope everyone will understand the importance of taking the time to get this right.
